2.4 Curriculum Institute recap

Lori Pullman presented on selected topic from the Curriculum Institute. She spoke about AB 1111 Common Course Numbering. Elizabeth Page spoke about AB 928 Cal-Getc, the crosswalk for CCC GE changes, and the Title 5 regulations related to the Associate Degree requirement, and the 8th edition of the PCAH.

She mentioned the assembly bills that are in process and AB 928 into a singular GE pattern. The overarching goal is streamlining the curriculum for students. It has been a difficult, layered process to align CSU breadth and IGETC. There is a webinar coming up on September 18th regarding AB 928 and the information was sent to the Curriculum Committee. D.E.I.A. was incorporated throughout the Curriculum Institute and improving integration into curriculum.

Marley Cervantes inquired about AB 928 implementation. Lori followed up with the timeline of Fall 2023 review of the standards and Fall 2025 implementation.

Mark Hamamura inquired about the courses going back through the articulation process. Manoj Wickremesinghe answered that courses approved for IGETC would be grandfathered in. If the course needs to be submitted for IGETC, it should be submitted for articulation by December. The Articulation Officers are currently meeting regarding AB 928 and should have a presentation together early spring.

VPA would like to add non-verbal communication back into the ISLO. Diane asked that the Curriculum Committee review and bring back to the next voting meeting.

Tabitha Liang and Mark Hamamura mentioned non-verbal communication with their fields.

Diane informed the committee that the assessment methods of the ISLOs are still being discussed.
