In accordance with federal regulations and the Commission [Policy on Monitoring Institutional Performance](#), ACCJC applies a set of annual monitoring and evaluation approaches to assess member institutions' strengths, stability, and ongoing alignment with the Standards during the course of the accreditation review cycle. The Annual Report (AR) is one of the tools used for this process. Using institutions' self-reported data, the ACCJC Annual Report collects headcount information to monitor institutional growth (including growth in distance and correspondence education) and institution-set standards for key indicators of student achievement, licensure exam pass rates, and job placement rates.

This focus has been paired with professional development. Additionally, the College has focused on expanding support programs for populations experiencing gaps in outcomes as well as with basic needs. Additionally, the College has been intentionally focusing planning to support the student pipeline by identifying where barriers are arising along that pipeline and among which student populations. Last, the College has been working towards student centered scheduling and meeting needs for students to complete degree and certificate pathways.

Professional development on culturally responsive curriculum and pedagogy is critical and part of the College's plans to mitigate gaps. The College has identified professional development to support a culture of care and support for our students as another priority.
