Welcome to Allied Health A010! The process of beginning all Allied Health programs (except EMS and Dietetics) is:

1. Successfully pass ALH A010 to be added to Interest List
2. While on Interest List, meet with a Counselor to build a Student Educational Plan (SEP)
3. Complete all the required courses [not major requirements] on the SEP
4. Once prerequisites are done {with final grades}, you **must** meet with ALH Counselor to verify completion.
5. If completed, ALH Counselor will give you a Program Readiness date and move you to the Program Ready List
6. Acceptance to a program is based on:
 - i. Program Ready date and then
 - ii. ALH A010 completion date

Successful completion of this course, and to be added to the Interest List, requires you to complete the following assignments and submit on the last day of class:

1. COMPLETED AND SIGNED APPLICATION

You will receive the application on the second to last day of class.

5. UNOFFICIAL OCC TRANSCRIPTS

- Print a copy of your unofficial OCC/GWC/CCC transcript from your MYOCC webpage and submit with your application.

6. PROVIDE ALL COLLEGE TRANSCRIPTS.

If you have already submitted official transcripts to OCC, you do not need to submit them again. If you are hand delivering outside transcripts, put your OCC Student ID# on the front of the envelope.

7. STUDENT EDUCATIONAL PLAN

Instructions for the Student Educational Plan (SEP):

To access Degree Works:

1. Log in to MyOCC and click on Student Tab
2. Launch Degree Works

- ✓ You must meet with a counselor to update your program of study
- ✓ Together, you must create a Plan for completing the course requirements for the Allied Health program you are applying to
- ✓ The plan must be locked by a counselor

- If you have transcripts from other colleges, allow 6-8 weeks after submission of transcripts to set up an appointment with a counselor to confirm your SEP. You must have a counselor confirm any courses completed at other schools.

- When developing the Student Educational Plan (SEP), it can be determined what, if any, courses transferred from other institutions only if all transcripts are on file with OCC

All students must obtain a Student Educational Plan for the Associates of Science degree to the specific program that you are applying to. All School of Allied Health programs offer the Associate of Science degree except EMS. For both Dental Assisting and Medical Assisting, the A.S. degree is optional. All other programs require the General Education courses for the A.S. degree.

8. COUNSELING APPOINTMENT WITH ALLIED HEALTH COUNSELOR

Once you have completed all the courses on the SEP (except major courses) with final grades posted, you then schedule a counseling appointment.

 - Complete Student Educational Plan (SEP)
 - Counseling appointment with Allied Health Counselor
