I. Preliminary Matters

- A. Call to Order: President Gordon called the meeting to order at 12:36 p.m.
- B. Public Comments: None.
- C. <u>Approval of the Minutes:</u> Motion 1: Secretary Kennedy moved to approve the March 19, 2024, minutes; approved with one abstention. Motion 2: Secretary Kennedy moved to approve the April 2, 2024, minutes; approved with one abstention.
- **D.** Executive Board Member Reports: Secretary Kennedy suggested that the roll call votes have a rotation so that each vote starts with the next person on the list, so the same person wouldn't be the first voter each time and that would be shared by all senators. The E-Board agreed.

- **B.** VPA Outside Discipline Tenure Track Committee Representation: The E-Board reviewed the volunteers' paragraph submissions and discussed if they met the requirements asked of volunteers. - **C.** Puente Counselor Hiring Committee Selection Process: President Gordon explained the process the Senate must follow, as per the CFE contract, as there were two tie departmental votes and that moves the vote to the full Senate for a decision to break the tie. The three who are tied will be asked to each provide a statement to the Senate as to why they should be selected. This item will be agendized for next week.

The VPA division will be notified that the Senate needs the name of their elected senator in a week. The E-Board agreed that the senator-at-large elections will be held after that.
