Resolution #S-2018-1, "Committee Member and Task Force Volunteer Appointment Selection Process": Secretary Kennedy reminded the E-Board of Resolution #S-2018-1, "Committee Member and Task Force Volunteer Appointment Selection Process," moved by Senators Blair and Kennedy and seconded by Senator Sachs, approved by the Senate on February 13, 2018. This resolution delineates the timelines and processes for Brown Act requirements and committee appointments provided by the Senate. It details the selection process, and contrary to general thought, allows committees, groups, or entities requesting a member appointment to list specific requirements or skills a volunteer should have to volunteer to be selected. The E-Board discussed this resolution and Secretary Kennedy said she would send out the resolution as an attachment to the E-Board following the meeting.
