1. Preliminary Matters

A. **Call to Order:** President Loren Sachs called the meeting to order at 11:30 A.M.

B. **Public Comment:** Chris Kerins

C. **Approval of the Minutes –**

Motion 1: Senator Kennedy moved to approve the April 20, 2021 minutes; motion seconded; motion approved.

D. **For the Good of the Order Announcements:**

Senator Cuellar: The CLEEO Summit 10.0 was well attended and well received. Luiz Valdez was very inspirational and the presentation he shared with the campus was very timely. It was clear that Mr. Valdez held OCC in high regard going back to his initial visit in 1972 when the Chicano Theater Conference was held at OCC. This concluded the CLEEO Summit 10.0 for the spring 2021 semester.

Senator Means: There is an international student in his division who has been struggling to make art express personal opinion and the student had to drop the class because the student's father was arrested. As faculty we are in a position to try to get people to express their opinions but without putting themselves in danger. Is there a way that the pressure of that on faculty is acknowledged campus-wide? This is incredibly upsetting to the faculty member and how is this dealt with? **Senator Kennedy** asked if Senator Means

could speak to her or someone from the Academic Freedom Committee regarding the art student.

Senator Phillips: This week is Black Student Success Week, and we are scheduled to have a championship panel of faculty speakers today via Zoom. This event was submitted to get publicized in Banner but for unknown reasons, it was not. There is a presentation each day at 3 PM called the Black Hour.

Dr. Anna Hanlon: The data workshop for CTE faculty has thirty faculty enrolled. This is a stipend workshop. If senators have CTE faculty they should encourage them to reflect to see if they have the time to complete it. There are lots of codes and dashboards and metrics used to evaluate the CTE programs, and the workshop trains on how they can understand where the numbers come from and provide context as it relates to their programs. Interested faculty can email Kelly Holt or Anna Hanlon.

Senator Alabi: Almost yearly she attends the Women Hold up Half the Sky conference, sponsored by the District and this year led by Dr. Dana Emerson of Coastline, held via Zoom on May 14. This year the conference is free. She is hosting a panel of women who have been thriving and striving in education and their careers but also who have encountered major challenges and barriers. It is a great panel and a great conference. She will provide more information.

2. Officer, Senator, & Committee Reports

A. President's Report – Loren Sachs:

- **Senator-at-Large Elections:** Announced that via a campus election, the new senators-at-large for the 2021-2024 are Eduardo Jesus Arismendi-Pardi, Eric Cuellar, and Clyde Phillips
- **Return to Campus Discussions:** The CPP is the outline that President Suarez shared campus-wide in an email yesterday. There is an opportunity at the next DCC meeting for faculty constituents to bring back faculty ideas and feedback. Please read the document again. Right now, the District's perspective is to follow the CAL/OSCHA guidance. Unfortunately, the CAL/OSCHA guidance has not been updated since September of 2020. It is evident that the pandemic has gone on a completely different path in the last three or four months. There is a little bit of a restriction in terms of the way it is being interpreted. Take a look at the document and bring any thoughts or ideas to President Sachs.
- **OCC President and VPs and Faculty Town Hall:** There is going to be a faculty town hall hosted by President Suarez and the VPs. It is scheduled for May 14 from 10 -11 am to discuss the return to campus. There could be some opportunities for discussion on faculty and students expressing opinions and international students and issues.
- **DCC Budget Subcommittee:** Met last week and are starting to put some numbers on the issue that when *hold harmless* fails what it starts to look like at the budget. That is upwards of five to ten million dollars to the District based on the continuing slide of decreasing enrollment.
- **College Council:** They are working on the Educational Master Plan. There will be a revision for the Academic Senate to look at in the upcoming weeks.
- **IPC:** Met last week to start the ARR prioritization process. There are about 378 ARRs in total this week.

B. Spring 2021 Plenary Update – Jessica A. Alabi:

Reported that as a member of the Executive Board of the Black Caucus they have been focusing on ethnic studies; there are five distinct areas in the requirements. There is Ethnic Studies itself, then Black Studies, African American Studies, Latino/a Studies, Native American Studies, and Asian and Pacific Islander Studies. They have been having summits with the ASCCC the last couple of months to discuss moving forward with those programs with their subject matter experts. The Ethnic Studies faculty is eliminating that area in Social Justice studies.

There are complexities as the California Community Colleges had tried to address ethnic studies through Social Justice Studies that had focuses on Ethnic Studies, Gender Studies, and sexuality [studies]. A group of members with backgrounds in Social Justice Studies thought that Social Justice Studies should focus on social justice. The TMC focuses on race, ethnicity, gender, and sexuality, but not actually social justice.

These issues were addressed in the OCC Curriculum Committee when OCC was starting a social justice program and why she submitted Social Justice 101 and 102. The students were actually wanting to study environmental justice, housing justice, racial justice, etc. They wanted to actually study social justice issues and get into nonprofit and activism.

When the law passed with the CSUs, the movement is now to discontinue social justice ethnic studies as we have Ethnic Studies, and to create an Ethnic Studies TMC. That is where we are right now, but it has not happened yet and the only thing that has happened is the area F requirement. They are connected in spirit, but not connected technically. Technically students will be required to complete ethnic studies to transfer into the CSUs and those Ethnic Studies classes have to be compliant with the requirements.

There were many Cal State articulation officers at our last summit talking about what they would and would not accept, what community colleges were doing and the watering down of ethnic studies. Putting ethnic studies on any class will not work because the Cal States are not going to accept just anything in area F. They will be looking closely at what colleges are doing.

The main issue was what if a student takes a class labeled “Ethnic Studies,” but they really want to be a Black Studies major, will that class count as Black Studies? The Cal State articulation officers were urging community colleges to actually start Native American Studies, Black studies, Latino/Latina Studies programs, etc., so that when those students transfer and they want to go into those programs, their credits actually count for those programs. CSUs have those programs. They have five different programs. Labeling everything “Ethnic Studies” may not work for a student who transfers.

As the Chair of Ethnic Studies within Sociology, she is working with her dean, faculty, and OCC Curriculum Chair and articulation officer and would like meet with the counseling faculty. Right now, there is not a lot of enrollment for the summer Ethnic Studies classes, and they are trying to determine if they should offer Ethnic Studies in intercession because they do not know if students are being told about the requirements and she is the only one from OCC attending all the summits and meetings.

Curriculum Chair Otwell stated that his understanding is Area F applies to incoming fall 2022 students. **Senator Alabi** and **Chair Otwell** agreed to review the effect dates for students.

Senator Alabi reported that also being debated is Senate Bill 3330 and whether California Community colleges are going to require ethnic studies for graduation. With the current political climate students and community are demanding more cultural

efficacy, knowledge, and awareness. This is not just about students of color, but about all students learning about the history and the experiences of all people in the United States. These are not classes just for students of color; these classes are as much for white students as they are for students of color.

President Sachs: The Spring 2021 Plenary resolutions will be posted on the Academic Senate public website.

- C. Budget Update – Cyndee Ely:** Followed up on her last report regarding “staff to enrollment” and clarified that there are positive things that can be done if we focus on looking deeply at the enrollment and using that as the guiding decisions for scheduling, course offerings, and program development. We have to look at what the students need to transfer and that should be guiding the decision making.
- D. Professional Development Institute (PDI) Report: PDI Chair Kennedy** reported that May 3 is the semester deadline to apply for PDI for salary advancement credits or funding for conferences all through the summer and early fall and these conferences have to be online.
- E. Institutional Effectiveness: – IE Coordinator Kelly Holt:** On April 15, they asked Nuventive, the owners of TracDat, to do a demonstration for faculty. A few faculty members joined the demonstration. TracDat is going to become Nuventive Improve, so they are going to move to a new platform in the fall. They are working on the migration. Right now, the company is taking feedback from the end users to determine the navigation. The screens themselves will not change much. It is mostly going to be related to the functionality, how they navigate through the different pages, which is going to be a lot more streamlined. They can also attach quick links and other types of links right within the page. It is going to be an improvement from what they had now. They recorded the presentation. Dr. Anna Hanlon is editing the presentation. They are trying to edit down to just important demonstrations. They had a few folks that expressed interest in giving feedback but could not make the time. If anyone would like to watch the video, they have a few guiding questions to gather feedback in terms of functionality and things they would like to see.

3. Unfinished Business

- A. Credit for Prior Learning (CPL) – Curriculum Chair Charles Otwell:** Reported that they are at a point where they would like to convene a Task Force. As per the make-up of the task force, his suggestion last time was that they consider having the discipline faculty rotate on and off of this task force as the areas of assessment that they are involved with. For instance, they would need faculty from Fine Arts when they are looking at the processes for portfolio assessment and awarding of credit and so on.

Senator Kennedy: Stated that she wrote a resolution that had originally been intended to be a brief motion ensuring faculty purview and decision making of CPL discipline-specific issues and would be willing to work with Curriculum Chair Otwell on the resolution and bring it back to the Senate. **President Sachs** asked that this be brought back next week due to time constraints with the elections on the agenda today.

4. New Business

A. Part Time Senator Selection for Spring 2021:

There were seven (7) nominations for the replacement part-time senator position for spring 2021: Jason Ball, Michael Beale, Daniel Goya-Lane, Richard Mayfield, David McMahan, Paras Nanavati, and Behnaz Razavi. Jason Ball, Daniel Goya-Lane and Behnaz Razavi introduced themselves and explained why they would like to be considered for P-T senators. The rest of the nominees were not in the meeting. Senators voted by roll call vote.

Jason Ball was elected as Part Time Senator for the remainder of Spring 2021 by a majority of votes.

C. BP/AP 7909 Emeritus and Meritorious and 5500 Student Conduct Policies – Senator Kennedy:

BP 7909 Emeritus Status: The Emeritus Status process right now is unclear. It is something that the Board of Trustees grants to people if they go through a particular process that seems to be confusing to many faculty, and there is no consistency across the three campuses. Golden West created their own Emeritus Committee, which is not allowed via board policy. Classified has added the *meritorious* status in this current revision which relates to classified, not faculty

This new revision was done by faculty at Coastline College because they felt that emeritus status was not being handed down equitably to faculty who retired in good standing. What they are proposing to change is that *emeritus* designation is automatically conferred on those who meet the above criteria of thirty (30) semesters if they leave in good standing. It still goes through the board, as everything does. The Committee was told that there were a couple of Board of Trustee members who might wish to add some requirements comparative to what universities require for emeritus status; however, there was some debate as many felt that this was not appropriate for community colleges.

Senator Kennedy reported that she researched through several colleges online to see if she could find what other community colleges do. There is absolutely no consistency. She asked for feedback.

Senator Arismendi-Pardi: Emeritus status for community colleges should be a function of service, not a function of research and investigation. That is only applicable to research institutions such as the Cal States and the UCs. The same goes with the academic titles that are seen in community colleges which are not a function of academic or scholarly work. It is a result of seat time and to require that community college faculty be given particular titles, that is a function of research. It is inappropriate because the community college is not a research institution; It is a teaching institution; therefore, the title should be granted as a function of teaching time.

Senator Kennedy: Encouraged senators to look at the Student Code of Conduct policy in the red areas. They are proposing to change the appeals process and limiting some lesser-issue appeals for students because they are bogging down the system. The second thing that is a larger concern with Golden West is on pages 15 and 16, as there was a particular situation at Golden West where a student threatened the teacher, went to their home and damaged property. Senator Kennedy will be with Golden West Academic Senate President on that language and some other areas of concern to the GWC Senate.

President Sachs: Asked for feedback regarding the return to campus documents and the policies.
