- 3. Officer, Senator, and Committee Reports:
- 1. **President's Report –** Andrea Rangno:

- 1. COVID-19
 - 1. Last week, the Chancellor announced that we would continue with level 2 of our return to campus plans
 - 1. Level 2 consist of 4 days a week operation with no more than 70% staff occupancy
 - 1. This does not mean we have to have 70% at all times. This simply means that departments have the flexibility to staff up to 70% if needed.
 - 2. Continuing indoor masking until said otherwise
 - 1. N95 masks can be requested through HR Manager, Rebecca Morgan.
 - 2. Please use surgical masks or N95s if possible. Surgical masks can be found in every department and office. Please talk to your supervisor.
- 2. Chancellor's Search Committee
 - 1. On Wednesday 2/16/2022, the Board of Trustee approved the change to BP 2431 to add on a Classified Senate representative on the Chancellor's hiring committee
 - 1. This is a major milestone for Classified Senate two years in the making. It started with Dr. Suarez's search committee, moving to CCC's President Search committee and now to the Chancellor's Search committee.
 - 2. This is an important step in the district recognizing the voices of Classified Senate and the value we bring to every decision-making arena.
