1. Call to Order - Classified Senate President:

President John Fawcett called the meeting to order at 11:02 a.m.

2. Approval of the Minutes - Classified Senate Body:

- 3. For the Good of the Order
 - Eric Wilson attended his first DET/CHE meeting with Senator Curtis Williams. It is a great organization where CSUs and Community Colleges technology faculty and staff get together. The DET/CHE has been going for thirty-eight years and Eric Wilson won the award for the best presentation on Artificial Intelligence (AI). It was very dynamic.

- Scott Broberg command that Katie Ottoson was in the room to present on AI. She has done fantastic things with AI. He is working with the OC Regional Consortium and Vital Link to organize an event for April 18. It will be dealing with AI and XR in education and industry. It is getting students prepared for the future of industry. It is in conjunction with those organizations in the Fine Arts lecture Hall.

- D. CFEP Report: Michael Carrizo CFCP and District canceled the negotiations meeting today. CFCP asked for some data, and they were not able to provide it. They are working with the State Affiliates to make sure that they see what CFCP sees. They are asking them questions for clarification. - B. Generative Artificial Intelligence (Canvas) "Think Tank" Eric Wilson:
 - We need to become educated on Artificial Intelligence.
 - He thought it would be a good idea to have an open Canvas site with resources, such as Zoom voice accessibility, etc. There are different modules.
 - He presented a demo. Within the home page, there are different modules. There will be training on AI.
 There is another page about tools. There will be open discussions. It is important to be open and transparent. We must include students in the conversation. It will be a way to communicate concerns and issues and creative ways of using these tools. There are so many "recipes" for teachers. There will also be a resource center. There will be on campus open forums.
 - The District is planning on creating a work group. It would be good to have a gathering place where people find out where to get started and how to find resources. The CA Chancellor's Office is hosting a series of webinars on AI.
 - Canvas can be accessed two ways. They can have it open and use an URL. People would just need to bookmark it. They will have to login as usual. The other way is to get registered. First timer can register, and the system will try to identify those who are allowable into the system.

- Students are wrongfully being accused of cheating using AI. This is something that needs to be addressed. AI is here to stay, and we need to learn how to navigate it. TurnItIn is not very good at detecting AI. There are too many false negatives. This needs to be looked at closely. We have an opportunity to think ahead.
- We need to use AI as a tool and not a weapon.
- C. ISER Review Sheri Sterner & Anna Hanlon Expectations for Classified Senate and Assigned Standards
 - Dean Sterner: Reviewed the new changes to the standards. It is less of a focus on evidence and a more of a focus on outcomes and improvement rather than our processes. There is a focus on equity and inclusion.
 - The new standards focus on the mission alignment of the college, on equitable outcomes, and a focus on innovation and improvement. They are asking the college to close the loop.
 - The major changes went from "repetitive and siloed" to "streamlines and holistic". From "do you have a process" to "what are the results, and how do you use them". From "Narrative Required for Everything" to "Some documentation provided via checklist". From 120 standards to 30 standards for all colleges. A lot of the requirements are not embedded in others. It is much less duplicated.
 - OCC is engaging the district on their district support and services where applicable.
 - They are providing us a template this time. The report needs to be 100 pages as compared to past years.
 - This is about reflecting on the statement, having that dialogue, wat are outcomes? What are we doing about it? where are our gaps? It is about having dialogue.
 - The report will be finalized by spring 2025. The ACCJC visit will be in the spring of 2026.
 - Classified Senate is being asked to participate in the technical review. The ACCJC has given prompts in the template to help facilitate conversation. Anna Hanlon reviewed the framework for reflection on statements.
 - The Classified Senate's Assigned Statement includes:

Standard 4: Governance and Decision Making: The institution engages in clear and effective governance practices that support the achievement of its mission.
