Attachment A - Proposed Bylaw Changes

Student Body President Changes

Change 1. Replace Part III, Article II, Section E, 6. Position Descriptions, IV, subsection a, with Modification A

iv. The Student Body President shall be responsible for fulfilling the duties of executive officers at such time as they are unwilling or unable to perform their duties by way of taking the responsibilities of the vacated position upon him or herselfthemselves, or by allowing a willing executive officer to accept those duties.

Change 1. Add Modification B to Part III, Article II, Section E, 6. Position Descriptions, IV, subsection a.

X. The Student Body President shall have the power to designate to the VP of Student Senate the ability to attend various required meetings on his or her behalf.

Regional Delegate Changes

Change 1. Add clause to Part III, Article II Section E, 6. Position Descriptions, F

VI. The Regional Delegate shall not serve on a position or hold an office in any statewide community college student organization in any club, organization, municipal, local, or state government that is recognized by the California Board of Governors position that is politically inclined and would constitute a conflict of interest (having an incentive to advocate for a constituency other than the entirety of ASOCC students).

Deletions:

Change 1. Delete Part III, Article II, Section E, 5. Powers, Duties, Responsibilities, B.

"The Executive Board shall have the power over all ASOCC monies, including the responsibility to approve budgets, authorize all expenditures, set fiscal policy, and conduct inquiries regarding the finances of ASOCC and any entities contained therein, so long at its actions are in compliance with policy set forth by Orange Coast College, the Coast Community College District, and California law."

Change 2. CLC Composition and Membership Deletions:

Delete the following contained within Part 3, Article II, Section B, 6. Position Descriptions, C Events Coordinator

4. Work closely with event chair(s) to update project sheets related to all College

Life Committee events

6. Assist event chairpersons with event layout for their activities (remove)

8 Chair the decorations sub-committee for each event (remove)

D. Historian

2. Collect newspaper clippings and correspondence related to College Life

Committee.

SGOCC Officer GPA Requirements:

Change 1. Part III, Article III, Section B.

Two alternative ways of writing the same thing:

IV. Students may not apply for any SGOCC officer positions within a year of receiving a semester GPA of less than a 2.0.

IV. All officers must not have had a semester GPA of less than 2.00 within one academic year of starting their position.

Executive Board Changes:

Change 1. Add into Article II, Section E, 2 -

Subsection D: The newly elected Student Senate shall appoint the Incoming Executive Board Officers.

Communication Committee Changes

Change 1. Change Part III, Article II, Section C, 2, c. to read

"Representation from the Student Senate to the Communications Task Force is not mandated since the Vice President of Communications serves as the liaison to the Senate. However, there shall be reserved and optional seats on the Communications Task Force for <u>1-3</u> <u>1-at least one and up to three3</u> Student Senators."

* Major change here is from one senator to up to three senators.

Change 2. Add to Part III, Article II, Section C, subsection 2, c. an additional subsection.

4. Meetings

a. Committee members shall hold no less than one meeting every two weeks on Fridays from 12:00 a.m. - 1:00 a.m. Thursdays 12:45 p.m. - 1:45

* This meeting time clashes with the current Student Senate meeting time (as does Sustainability's meeting time). If a Clause is added to the Student Senate eligibility requirements that stipulates a Senator's participation on at least one of the Senate and E-Board's committees or taskforces, then these meeting times must be changed.

- b. Meetings are to be held in alternation with those of the Sustainability Committee.
- c. The Communications Committee shall consist of at least six members, but no more than eight members.

Change 3. Add to Part III, Article II, Section C, subsection 3:

C. The Communications Committee shall host:

5. Duties

i. It shall be the duty of the Communications Committee officers to host the events listed below at least once a year including, but not limited to:

1. Informative-Events

- a. Student Senate Elections
- b. Open House

c. Social Media Day (one once per semester)

2. Campus Activities

a. Social Media Day (one once per semester)

Student Senator Changes:

1. Add to Part III, Article II, Section I, 6., subsection C.

vii. Student Senators must sit serve on at least one of the Senate and Executive Board's standing committees, Ad-hoc committees or task forces.

Minor Changes:

1. Change "College life advisor" into "Student Life Advisor-Coordinator" every place it occurs.

2. Section G, 5, Section B would change Dean of Student Services to "Director of Student LHife"

3. Anytime it says ICC advisor, change to "Student Life Coordinator"

Drafts and Other Considerations:

Consideration 1: General Appeals Process -

A. All SGOCC position <u>Student Senate</u> appeals submitted to the SGOCC student senate will be properly reviewed, accepted or declined, investigated, and resolved by the student senate's Constitution and Bylaws Standing Committee, in the company of a faculty supervisor.

B. An SGOCC position appeal must be submitted no later than one week from the time of disqualification for an elected position.

C. An SGOCC position appeal must be submitted no later than one week from the denial of an appointed position.
