Article II: Branch Bylaws

Section H: Sustainability Committee

- 2. Composition and Membership
 - 1-a. The Sustainability Committee shall consist of at least five members, including the Chair of the Sustainability Committee, and no more than nine.
 - 2.b. By virtue of the office of the The Vice President of Fiscal Affairs, the Vice President of Fiscal Affairs or a designee from the Fiscal Affairs Council, shall hold membership on the

Sustainability Committee. Additionally, the Fiscal Affairs Council shall appoint, from its body, at least one, and no more than two, representative(s) to the Sustainability Committee.

- 3-c. The Student Senate and Executive Board shall appoint, from its body, no more than three least two, and no more than three, Student Senators or Executive Board officers to the Sustainability Committee.
- 4.d. The Fiscal Affairs Council shall appoint, from its body, two representatives to the Sustainability Committee.
- 5.e. The Sustainability Committee eanshall appoint up to three membersat least one, and no more than three, representative(s) from other branches in SGOCC. The Student Senate shall ratify these appointments.
- 4. Powers, Duties, Responsibility
 - 3.c. Recycling Pick-ups
 - 2.ii. Participation in recycling pick-ups is mandatory for each committee member, or their designee, as outlined in the "Attendance" section of the Sustainability Committee's bylawsSGOCC Policy 1004: SGOCC Attendance/Truancy.

- 1.a. Chair of the Sustainability Committee
 - 4.i. Shall be the liaison between SGOCC's Student Senate and Sustainability Committee.
 - 2.ii. Prepare and post meeting agendas in compliance with all state laws.

 - 1-iv. Enforce all rules established in these documents.
- 2.b. Vice Co-Chair of the Sustainability Committee
 - i. Shall perform the duties of the Chair at such time as the Chair is unable to perform them.

c. Secretary

- i. Shall take minutes of all official Sustainability Committee meetings.
- ii. Shall send minutes to the Sustainability Committee Chair and the Advisor within 48 business hours of the Sustainability Committee meeting so that they may be made available to the public.
- iii. Shall write and send thank you letters as necessary.
- iv. Shall take attendance for all official meetings.
